**Membership dues** to Mu Phi Epsilon are **not** a tax-deductible donation. They may be tax-deductible as a business expense if they can be justified as important to your business activities.

Payments for ticketed events, for fundraiser dinners, or for other activities where value is received are not tax-deductible.

The Ann Arbor Alumni Chapter of Mu Phi Epsilon is a 501(c)(7) non-profit organization. Donations made directly to the chapter are **not** tax-deductible, although donations to the Mu Phi Epsilon International Professional Music Fraternity are . . . . because it is a 501(c)(3) charitable non-profit organization. Donation checks for the Ann Arbor Alumni chapter should be made payable to "Mu Phi Epsilon – Ann Arbor".

We are confident that our Chapter patrons and other donors will continue to give to the Ann Arbor Alumni chapter because they believe in our mission of promoting musicianship locally, developing true bonds of friendship throughout the world through music, making our community more beautiful through our individual and collective involvement in music, and ~ most importantly ~ achieving our aim of serving and supporting the Mu Phi collegiates of our local area, both musically and financially.

The International Executive Office files a yearly federal Form 990-N for each chapter with the IRS. Individual chapters in general should not file this form, however if an individual chapter's fiscal year's receipts exceed \$25,000, it needs to contact the IEO and file its own Form 990-N and possibly hire an accountant, preferably a CPA, to prepare the return. If an individual chapter receives any communication from the IRS it should contact the IEO before taking any action.
